We value your support of EPI, and we want to assure you that each dollar raised supports the individuals that partner with us for services.

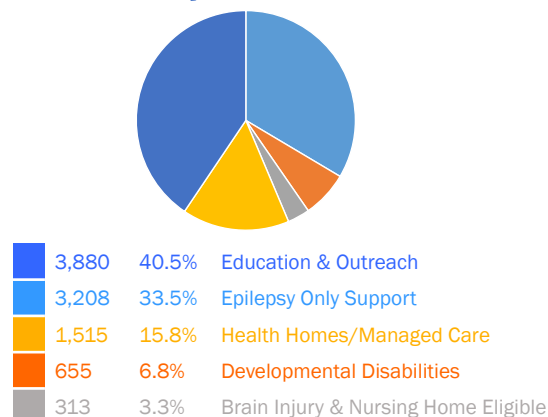
General administrative costs: 7.4%

Binghamton

By the end of 2016, our new Binghamton group homes and day programs had a full year of operation. The 10 individuals we serve in those programs came to us from the Broome Developmental Center and have nicely transitioned into their communities.

Health Homes

We've experienced continued expansion with Health Homes, providing care coordination to individuals with disabilities and intensive medical needs (matching the growth from 2015 at 15.8%).

Keeping People in their Homes

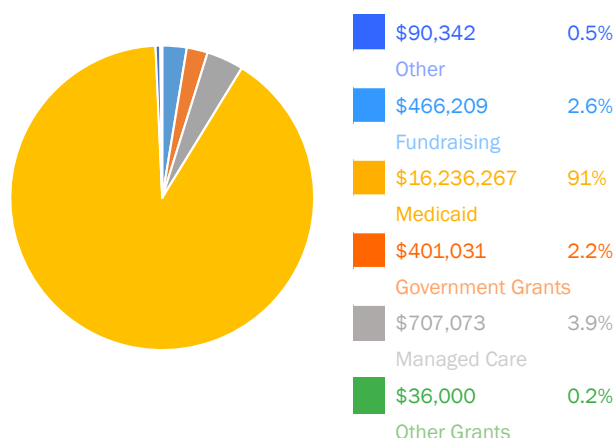
In 2016, we were able to provide \$1 million in environmental modifications and adaptive equipment to keep more people with disabilities in their own homes, longer. This is a 45% growth from 2015.

2016 Grants

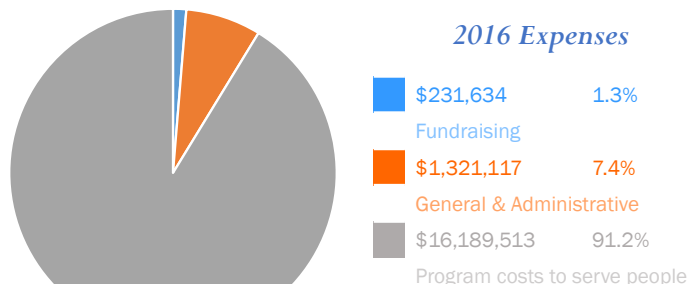
Our highlight of the year was a \$319,000 grant that will enable us to increase fire safety in our residential homes. Other grant successes in 2016 include a \$73,000 grant to train Personal Care Aides as Home Health Aides and a \$40,000 grant to upgrade our medical records.

- 2017 offers some great opportunities as well when we look ahead.
- EPI is in the process of achieving Person-Centered Excellence Accreditation Council on Quality and Leadership (CQL) certification — which will enhance and drive our person-centered approach.
- Through partnerships, we expanded respite care services in February.
- EPI is becoming an owner of a care coordination organization with our first foray into Managed Care for individuals with developmental disabilities,
- EPI is joining Al Sigl and Abilities First, establishing Monroe Housing Collaboration which will connect individuals with developmental disabilities to more housing opportunities in Monroe County.
